Adjustment/Analysis of 2020 Civil Unrest Claims

This session will provide an overview of the challenging coverage issues faced by the industry in addressing first-party claims arising from the civil unrest that occurred throughout the United States starting in May 2020. For insureds that experienced losses across multiple locations in many states, insurers were faced with adjustment decisions based on evaluating the number of per-"occurrence" deductibles to apply. Although a body of case law has been developed among many states that has been cited as precedent on CAT losses, and specifically riot, "civil commotion" or "vandalism" losses, questions were raised about the precedents' application over losses involving such a wide geographic scale. The overwhelming number of incidents also made it difficult to employ the usual fact-gathering efforts for these claims. In addition, insurers were also obliged to consider the potential applicability of broad "civil commotion" or "terrorism" exclusions, in light of the political, socio-economic, and moral climate that developed during this time. Interesting differences in the policy definitions of "occurrence," choice of law/forum clauses, the significance of the "CAT 2033" designation, the nature of the losses themselves (e.g., violence during or following a protest or random acts of vandalism), the number of locations, and their potential geographic similarity, all have played into the creative ways that insurers continue their ongoing efforts to resolve these claims and/or to limit the coverage issues that would have to be adjudicated by a court or arbitration panel.
